

Shows whether training certificates are uploaded into Researcher Profile of Study team.


PI/Study team can add the Co-Is noted on the study to the email list so they would receive all emails regarding the study.

PI/Study team can withdraw a study from consideration. This activity is only available in certain states, otherwise, the PI/Study team can log a comment to request the study be closed on their behalf.

Allows PI to submit the application for review.
