UCalgary Expression of Interest (EOI) for Canada Impact+ Research Training Awards

On Dec. 9, 2025, the Tri-Agency launched the Canada Impact+ Research Training Awards as part of the Government of Canada's International Talent Attraction Strategy and Action Plan. The University of Calgary has been allocated 19 doctoral student nominations and 11 postdoctoral nominations. This Expression of Interest (EOI) collects information to facilitate an institutional selection of nominators and nominees to fill these spots.

- Expressions of Interest must be submitted (via this form) by **January 28, 2026**
- Notice of results of internal selection process will be sent **February 9-13, 2026**
- Full UCalgary nomination packages must be submitted by **February 27, 2026**
- Final nomination packages must be submitted to Tri-Agency Institutional Programs Secretariat (TIPS) by **March 4, 2026**

"Nominator" in this form means the UCalgary researcher who is seeking to nominate a doctoral or

postdoctoral scholar. "Nominee" means the person who would be nominated to join UCalgary as a doctoral student or as a postdoctoral scholar.

Eligible members of the academic staff may propose to nominate more than one individual; however you must submit a separate instance of this form for each nominee.

If you still do not receive a confirmation, you may need to resubmit the form. You may submit test submissions of the form, but if you do so please be sure to mark them clearly as "TEST" in a text field so they can be easily identified.
