



Canada Research Chair (Tier II), Cybersecurity Law, Faculty of Law

The **Faculty of Law** at the **University of Calgary** invites applications for a **Canada Research Chair (CRC) Tier II in Cybersecurity Law**. The successful candidate will be appointed at the rank of **Assistant Professor (Tenure-track) or Associate Professor (With Tenure)** and will be nominated for a CRC Tier II. The University of Calgary requires the successful candidate will have a PhD in Law, together with and relevant post-doctoral experience. The anticipated start date is July 1, 2019.

Tier II Chairs are intended for exceptional emerging scholars (i.e., candidates must have been an active researcher in their field for fewer than 10 years at the time of nomination). Candidates who are more than 10 years from having earned their highest degree and who have had career breaks, such as maternity, parental, or extended sick leave, clinical training, etc., may have their eligibility for a Tier II Chair assessed through the program's Tier II justification process. The Chair will establish an active research program that focuses on Cybersecurity, supported by external funding, and aligned with the University of Calgary's, and the Faculty of Law's strategic plans. Additionally, the Chair will play an important role in teaching and research supervision of students in Law undergraduate and graduate programs. Service to the department, faculty, University, and community is also expected.

The Chair will have the opportunity to be part of a prolific and diverse research environment in the Faculty of Law, with access to state of the art core infrastructure. Outstanding opportunities for collaboration are available with established research programs in Computer Science, the Centre for Military, Security and Strategic Studies and elsewhere in the University.

The successful candidate at the **Assistant Professor** level must demonstrate evidence of a track record of publications in high quality journals, securing external research funding, and effectiveness in teaching at the University level.

The successful candidate at the **Associate Professor** level must demonstrate evidence of a strong track record of publications in high quality journals, evidence of securing ongoing external research funding, effectiveness in teaching at the University level, and evidence of effective graduate student supervision.

Applicants will have earned a Ph.D. in Law or cognate area. Given the centrality of connections with the Calgary Bar and business communities to the success of this position, membership in the Law Society of Alberta would be an asset.

The University of Calgary's Faculty of Law is in the midst of a sustained period of growth and renewal. In its Strategic plan Energy.Innovation.Impact. UCalgary Law set itself the dual goals of enhancing its

international eminence in the areas of energy, environmental and natural resources law and continuing its position of national leadership in the area of experiential learning. The successful candidate for this position can expect to join, and lead, various interdisciplinary initiatives involving colleagues from Computer Science, the Centre for Military, Strategic and Security Studies, and elsewhere in the University.
