

Call for Abstracts

We are excited to announce that the **One Health Antimicrobial Stewardship Conference**, postponed from May and November 2020, will now go forward as a virtual conference on **March 10-12**, **2021**. (https://ohab.ca/one-health-2020/) We do apologize for the changes.

The Program Planning Committee of the 2021 Virtual One Health Antimicrobial Stewardship Conference invites interested people to submit abstracts or update previously submitted abstracts related to all aspects of antimicrobial stewardship in Animal Health, Public Health and/or Environmental Health. Trainees are encouraged to submit abstracts, even for work in progress. Our aim is to highlight current research that informs antimicrobial stewardship as well as programs or knowledge translation activities that are active in this area.

Trainees are expected to be currently enrolled in an internship, residency, technical program, undergraduate degree, graduate studies or postdoctoral fellowship at an accredited educational institution. This includes trainees in animal health technology, veterinary medicine, science, medicine, dentistry, pharmacy, agriculture, policy, biological sciences, social sciences and other related disciplines.

Instead of a poster session, the conference will feature short (10-minute) oral presentations submitted in advance as videos with slides. These videos will be available for viewing by all conference attendees. There will also be a platform for questions and answers.

Trainees with accepted abstracts will participate in a video presentation competition. There are cash prizes to be won! Winning videos will be chosen for short oral presentations during the main conference.

ABSTRACT SUBMISSION GUIDELINES

Format:

- Title
- Authors and affiliations; please indicate presenting and corresponding author(s)

- Structure:
 - Introduction
 - Material and methods
 - Results or anticipated results
 - o Conclusions or anticipated important conclusions
- 500-word limit excluding title, authors and affiliations
- Figures can be included: each figure will count for 50 words (figure captions count towards the abstract word count).
- If tables are included, their text will count towards the abstract word count.
- English language only
- Black 12-point Times New Roman font, single-spaced
- The abstract should be in a MS Word document, with one-inch page margins (all sides)
- Include a 250 character Tweet that can be sent out during the conference that summarizes the abstract, and that includes the following hashtags: #OneHealth #AntimicrobialStewardship (hashtags count towards the character count; the Tweet does not count towards the abstract word count)
- Indicate if the presenter is a postdoctoral fellow, PhD Student, Masters Student, Undergraduate Student, AHT student, intern, resident, etc.
- Indicate if you are interested in being considered for student presentation (oral and poster) awards and/or travel sponsorship.
