
### SSHRC Program Architecture



### **Subject Matter Eligibility (1)**

- Applications to SSHRC are reviewed for eligibility based on SSHRC's <u>General Guidelines for the</u>
   <u>Eligibility of Subject Matter</u> respecting the following criteria:
  - The objectives of the proposed research or related activities must be primarily in the social sciences and humanities (aligned with SSHRC's <u>legislated mandate</u>).
  - The intended outcome of the research must primarily be to add to our understanding and knowledge of individuals, groups and societies.
- Applicants should apply to the agency that is responsible for the <u>dominant research discipline or</u>
   <u>area</u> as defined by the agencies' <u>"Selecting the Appropriate Federal Granting Agency"</u> and <u>General Guidelines for the Eligibility of Subject Matter</u>.






### Multiple Applications Regulations



### Support of Tools for Connection-Related Activities

- Applicants can use grant funds up to \$50,000 to develop connection-related tools for the purpose of knowledge mobilization activities.
- Please see our <u>Guidelines for support of Tools for Research</u> and Related Activities application process for more information.



### **Indigenous Research**

In May 2015, SSHRC launched new initiatives to support and promote Indigenous research and talent development.

Indigenous research <u>statement of principles</u> will serve to guide the implementation of SSHRC's current and future activities.

A revised definition of <u>Indigenous research</u> clarifies research "by and with" Indigenous Peoples and emphasizes and values the existing strengths, assets and knowledge systems of Indigenous Peoples and communities.

<u>Guidelines for the Merit Review of Indigenous Research</u> are intended to assist committee members in interpreting SSHRC's specific Challenge, Feasibility and Capability evaluation criteria in the context of Indigenous research.



### Research Data Management Capacity Building Initiative

- SSHRC intends to fund up to 10 meritorious proposals per competition to help the Canadian social sciences and humanities research community strengthen its capacity for data management
- Research Data Management Capacity Building Initiative applications are subject to the Connection Grants evaluation criteria and scoring. In addition, the merit review committee will evaluate the degree to which applications respond to the objectives of the call, as listed on this slide.



## Research Data Management (RDM) Capacity Building Initiative

### Intended to fund activities that:

- develop and/or adopt data management standards, practices, tools and skills
- connect researchers or students with data management professionals and service providers
- share and develop knowledge and skills relating to data collection and storage, metadata, preservation, retention, sharing, credit and citation
- share and develop knowledge and skills related to data used or created in the context of Indigenous research
- enable the social sciences and humanities research community to meet the requirements of the <u>Tri-Agency RDM policy</u>



### Convening the Canadian Meta-Research Community Connection Grant

### **Objectives:**

- Bring together researchers, policy-makers, and/or stakeholders in metaresearch from diverse research fields across Canada to enable knowledge sharing and relationship building.
- Advance coordination and collaboration in Canadian meta-science through the development of a roadmap, gap analysis, research agenda or other output.
- Advance the relevance and application of Canadian meta-science to research and research-funding policy and practice in Canada.

Value and duration: \$50,000 for one year

**Deadline:** February 1<sup>st</sup>, 2026

SSHRC will fund a maximum of two applications under this special call.

My Connection project is strictly an Outreach Activity – who should I include as a Presenter?

For Connection projects, "Presenters" are not only people who will give a presentation at an event. Presenters are defined by SSHRC as individuals who will make an active contribution to the project's objectives and/or the production of concrete deliverables (e.g. preparing exhibition materials, producing a podcast). You can think of them as participants.



#### Are recurrent annual events eligible for Connection Grant support?

Yes, recurrent annual events are eligible for Connection Grant support, but you must demonstrate how the event differs from what was previously funded (e.g. what new knowledge is being mobilized, what new methods are being used).

### Frequently Asked Questions

I have been invited to a conference abroad; can I apply for a Connection Grant to support my travel expenses?

No. Connection Grants are not travel grants. They are intended to support applicants and project directors who are running a knowledge mobilization event or activity. Connection funding can support applicants' travel costs and other expenses if they are organizing an event or activity abroad. In this case, the applicant must demonstrate within the application why the event needs to be held outside Canada and its potential to mobilize Canadian research on an international stage.



#### What role can students have on a team?

Individuals enrolled in a program of study are not eligible to apply as applicant, project director, or co-applicant, regardless of their professional affiliation.

Students can be collaborators. Students who are collaborators on a project team cannot be paid a stipend or wage by the grant.



Can my application include bursaries to encourage increased student attendance?

No. Students must have an active role in your Connection project in order to be eligible for support.



How do I know if something is eligible for SSHRC support?

SSHRC grants are governed by the Tri-Agency Guide on Financial Administration. If you are not sure whether something you are proposing would be eligible, please contact us. Funding opportunity eligibility rules will be considered alongside Tri-Agency Financial Administration rules — meaning that eligible and non-eligible expenses specific to the Connection Grants prevail over eligible and non-eligible expenses outlined in the Guide.



I just learned that my Connection Grant proposal was not successful. Can I resubmit for the next competition?

Individuals, as applicants or project directors, can only apply to the Connection Grants funding opportunity once per calendar year.
